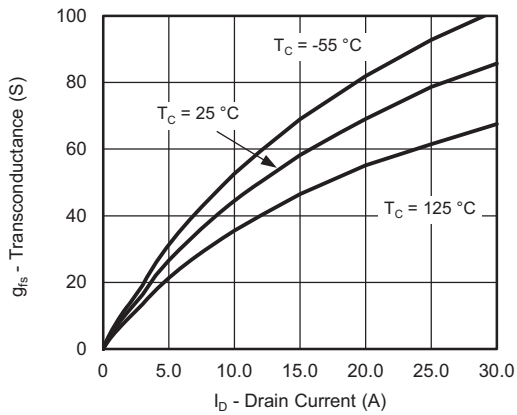

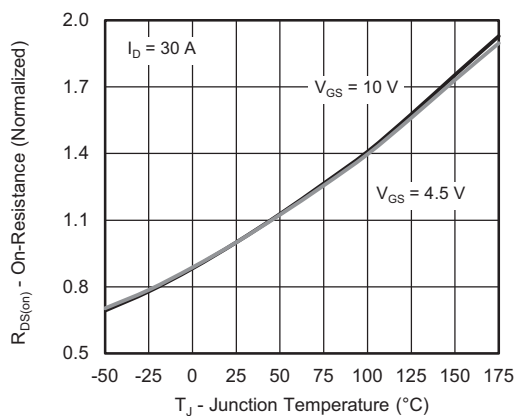
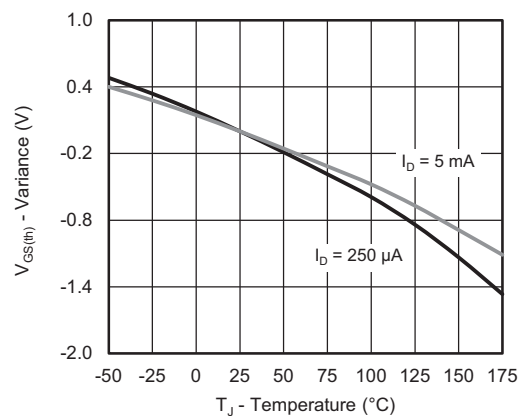
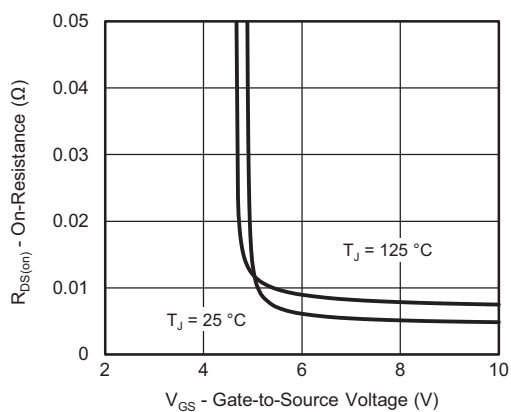
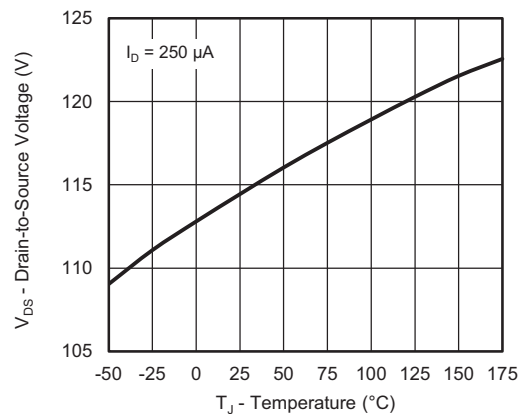
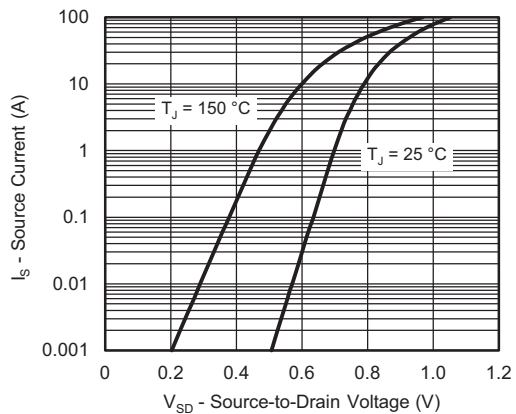
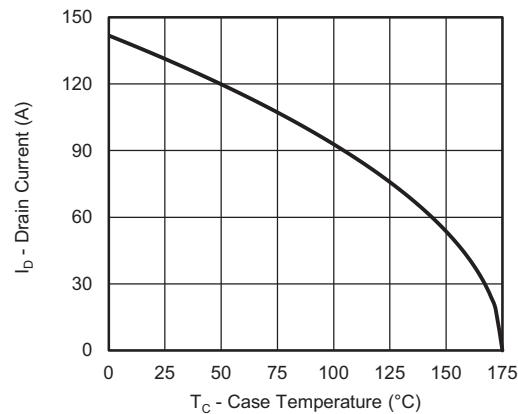
On-Resistance vs. Drain Current



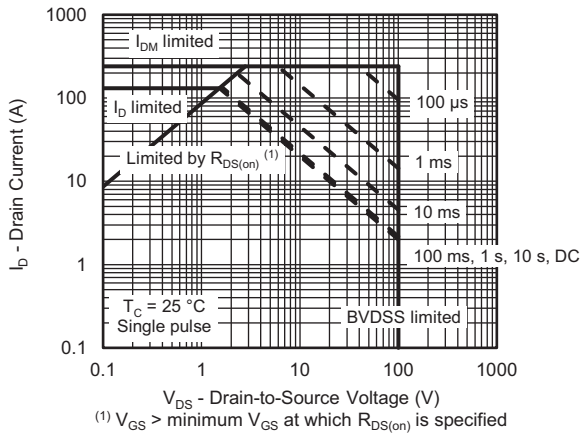

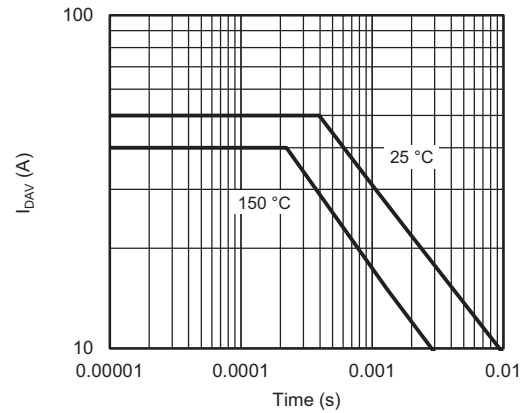

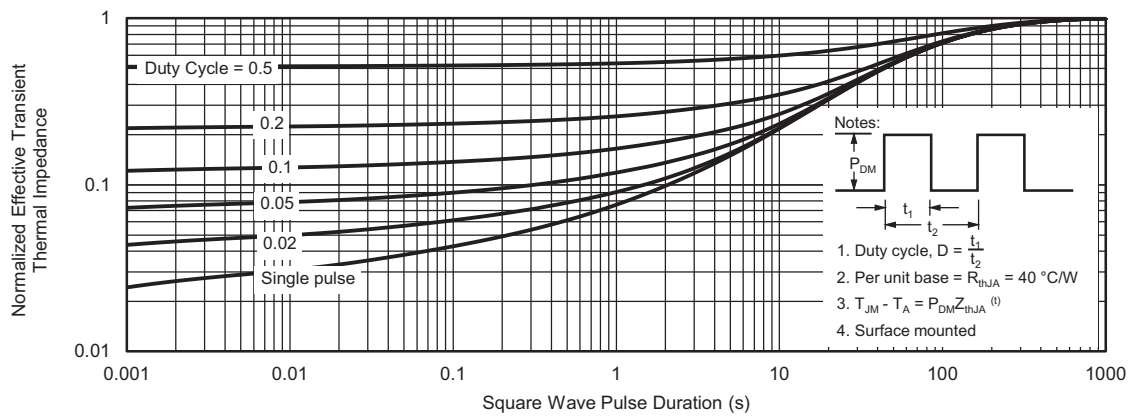

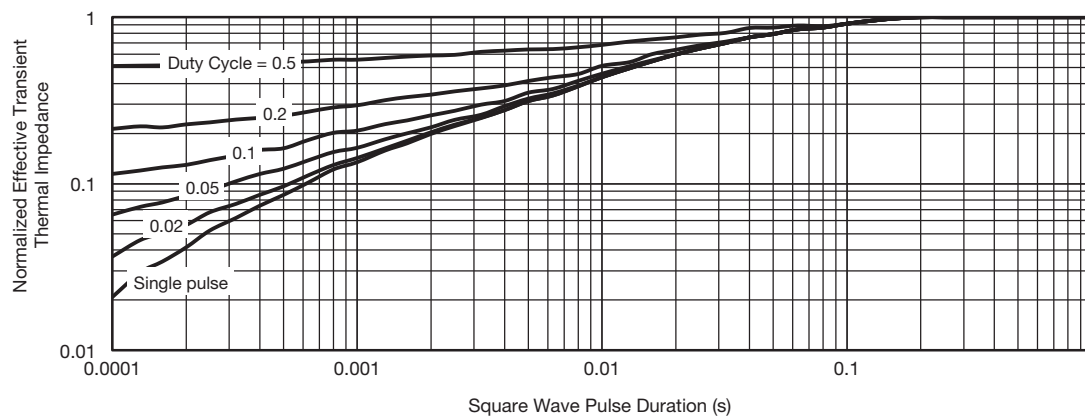
Safe Operating Area

Normalized Thermal Transient Impedance, Junction-to-Ambient

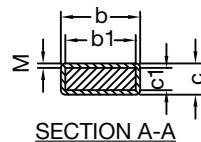
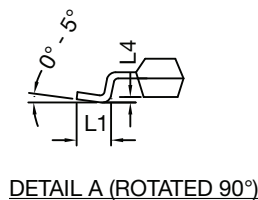
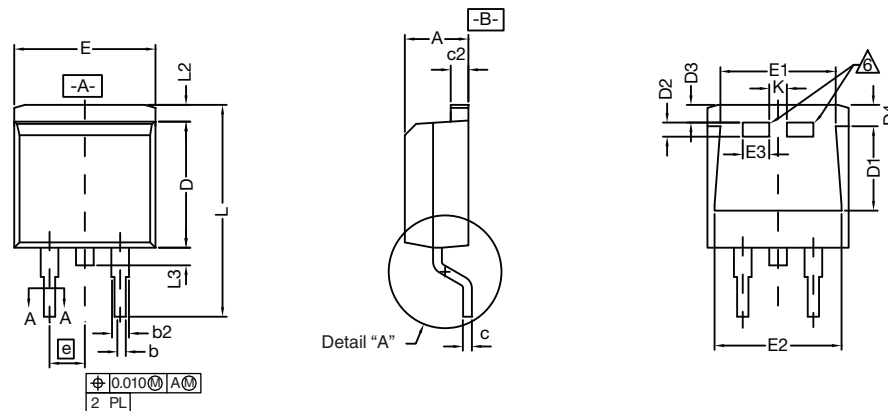
