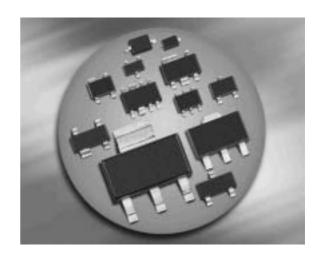

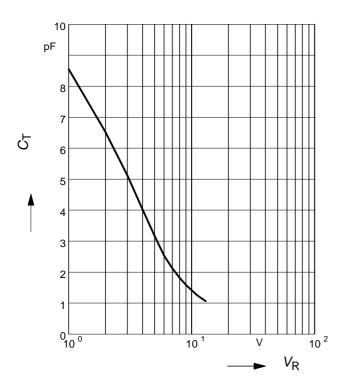

Diode capacitance $C_T = f(V_R)$

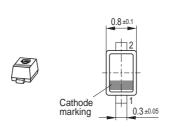

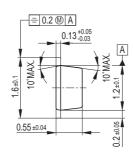

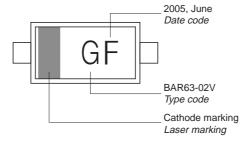




Foot Print



Marking Layout (Example)

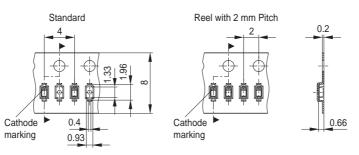
