






Figure 4. Gate Charge




Figure 5. Capacitance





Figure 6. Threshold Voltage vs Temperature

Figure 7. On-State Source-to-Source Resistance vs Gate-to-Source Voltage







Figure 9. Maximum Safe Operating Area




#### 7.2 Recommended PCB Pattern




