


The TS3USB221A is a high-bandwidth switch specially designed for the switching of high-speed USB 2.0 signals in handset and consumer applications, such as cell phones, digital cameras, and notebooks with hubs or controllers with limited USB I/Os. The wide bandwidth (900 MHz) of this switch allows signals to pass with minimum edge and phase distortion. The device multiplexes differential outputs from a USB host device to one of two corresponding outputs. The switch is bidirectional and offers little or no attenuation of the high-speed signals at the outputs. It is designed for low bit-to-bit skew and high channel-to-channel noise isolation, and is compatible with various standards, such high-speed USB 2.0 (480 Mbps).

The TS3USB221A integrates ESD protection cells on all pins, is available in a tiny μ QFN package (2.0 mm × 1.5 mm) and is charaterized over the free air temperature range from -40°C to 85°C.








Figure 1. Gain vs Frequency




Figure 2. OFF Isolation vs Frequency




Figure 3. Crosstalk vs Frequency






Figure 5. r_{ON} vs V_{IN} ($I_{OUT} = 30$ mA)




Figure 6. Eye Pattern: 480-Mbps USB Signal With No Switch (Through Path)

Figure 7. Eye Pattern: 480-Mbps USB Signal With Switch NC Path





Figure 8. Eye Pattern: 480-Mbps USB Signal With Switch NO Path

Figure 9. Turn-On (t_{ON}) and Turn-Off Time (t_{OFF})




Figure 10. OFF Isolation (O_{ISO})




Figure 11. Crosstalk (X_{TALK})




Figure 12. Bandwidth (BW)






Figure 13. Propagation Delay

Figure 14. Skew Test




Figure 15. ON-State Resistance (ron)




Figure 16. OFF-State Leakage Current




Figure 17. Capacitance

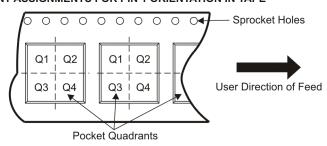


