## FlexRay bus ESD protection diode

## 1. General description

PESD1FLEX in a small SOT23 (TO-236AB) Surface-Mounted Device (SMD) plastic package designed to protect two automotive FlexRay bus lines from the damage caused by ElectroStatic Discharge (ESD) and other transients.

## 2. Features and benefits

- Due to the integrated diode structure only one small SOT23 package is needed to protect two FlexRay bus lines
- Max. peak pulse power:  $P_{PPM} = 200 \text{ W}$  at  $t_p = 8/20 \mu\text{s}$
- Low clamping voltage:  $V_{CL} = 40 \text{ V}$  at  $I_{PP} = 1 \text{ A}$
- Ultra low leakage current:  $I_{RM} = 1 \text{ nA}$
- Typ. diode capacitance matching:  $\Delta C_d/C_d = 0.1 \%$
- ESD protection up to 23 kV
- IEC 61000-4-2, level 4 (ESD)
- IEC 61000-4-5 (surge);  $I_{PPM} = 3 \text{ A}$  at  $t_p = 8/20 \mu\text{s}$
- Small SMD plastic package
- AEC-Q101 qualified








**Fig. 5. Diode capacitance as a function of reverse voltage; typical values**



## 10. Application information

The device is designed for the protection of two automotive FlexRay data lines from the damage caused by ESD and surge pulses. The device supports a FlexRay data rate of 10 Mbit/s and provides a surge capability of up to 200 W per line for an 8/20  $\mu$ s waveform.

### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.




Fig. 8. Package outline SOT23




Fig. 9. Reflow soldering footprint for SOT23




Fig. 10. Wave soldering footprint for SOT23
